Call to Order

Mayor Leslie Thompson called the Regular Meeting to order at 6:05pm.

Mayor's Town Update-The Town is where you need to come to get an update and to know what's really going on in the Town of Jonesboro. Here you can get the facts, ask the questions and have the Council respond to you. We have been challenged with water and sewer issues for 10, 20 years. In addition, we are hearing complaints about water bills. The Town is working aggressively to try to correct these problems. The tanks are kept pretty full and this is done to avoid low water pressure but the pipes are old and this is causing leaks. We are addressing the situation and we are correcting 3 or 4 leaks a day. We are asking you to please be patient with us, we are getting there. The last issue is the water bills. There are a lot of water bills that folks owe that are over 90 days old. We cannot have this and when the auditors get here, they will be looking at that. We have 30 days usage and the bills should be paid in 30 days. We have a policy in place now to help citizens who can't pay their bill. They will sign an agreement to pay the current bill and 10% of the past bill. Lastly, we did a quick assessment on the sewer issues that cost us \$10,000.00. We were commended by KNOE News Reporter (who specializes in wastewater) on the equipment and the aggressiveness that's being put forth to fix these issues.

2019/2020 Fiscal Budget

This is an area we have been working on for the last 6-7 months. I commend the work that Mr. Ginn has put into the budget, they are really good-looking numbers. As a new Councilmen Mr. Ginn has done a great job. We are much closer now then we were before.

Ginn- We based the budget on the best information we had. The information when it comes to the expenses, is accurate information. The revenue side was pretty easy to look at, and pretty clear cut. I think we should fix what we have instead of starting the process over.
